**Subject: Head Start in the House Committee on Education and Labor’s FY2021 Reconciliation Recommendations**

**This memorandum was prepared to enable distribution to more than one congressional office.**

On February 9, 2021, the House Committee on Education and Labor met to consider recommendations in response to reconciliation directives contained in the FY2021 budget resolution (S.Con.Res. 5).<sup>1</sup> Section 2205 of the committee’s reconciliation recommendations calls for a one-time mandatory appropriation of \$1.0 billion for the Head Start program in FY2021. (Typically, Head Start is funded with discretionary appropriations, so this would represent a break from precedent.) These funds would remain available for obligation by HHS through the end of FY2022 (September 30, 2022).

Section 2205 would effectively override the regular statutory allocation formula in the Head Start Act. Instead, these funds would be distributed to Head Start agencies on the basis of enrollment. In addition, HHS would be authorized to use these funds for federal administrative expenses. Section 2205 does not specify a cap on amounts HHS may reserve for this purpose.

**Table 1** presents estimates of the \$1 billion in Head Start appropriations proposed by the committee’s reconciliation recommendations, along with actual and estimated allocations provided by HHS for recent supplemental Head Start appropriations provided to prevent, prepare for, and respond to the Coronavirus Disease 2019 (COVID-19). Specifically, Head Start received

- \$750 million in supplemental discretionary appropriations in FY2020 from the Coronavirus Aid, Relief, and Economic Security Act (CARES, P.L. 116-136) and
- \$250 million in supplemental discretionary appropriations in the Coronavirus Relief and Response Supplemental Appropriations Act (CRRSA, Division M of P.L. 116-260).

These supplemental discretionary appropriations were allocated by HHS<sup>2</sup> on the basis of enrollment, similar to the way funds under the committee’s reconciliation recommendations would be distributed. Since HHS has access to more current enrollment data than Congressional Research Service (CRS), the reconciliation estimates allocate the proposed funds on a basis that is roughly proportional to actual and estimated HHS allocations from these recent supplemental appropriations. (The CRRSA Act allocations

are considered estimates since HHS had not yet distributed these funds as of the date the allocation estimates were shared with CRS.) CRS assumed that HHS would reserve 0.5% of the total appropriation for federal administrative expenses. This is comparable to the share of funds reserved by HHS for this purpose from the CARES Act, but is more than HHS reserved from the CRRSA Act.

Please note that the reconciliation estimates below were developed in time-limited circumstances and are *intended to be illustrative only*. Should these recommendations become law, the U.S. Department of Health and Human Services (HHS) would be the federal agency tasked with allotting these funds.

The reconciliation estimates are intended to be used for illustrative purposes only. HHS is the federal agency responsible for awarding these funds. Amounts in this table may not sum to totals due to rounding.
